

## \$10,000 Scholarship Raffle

### DRAWING RULES:

One \$10,000 scholarship will be awarded to the winning ticket holder, payable directly to any postsecondary institution of the winner's choice. The scholarship can be applied to any cost billed through the institution, or an endowment or donation in the winner's name may be made to any accredited school.

Tickets will be sold from February 2018 through 5:00 p.m. on Friday, April 20, 2018, or until all 1,000 tickets are sold. The drawing will be held at the 7<sup>th</sup> annual Duneland Education Foundation Gala at The Spa Special Event Center. Tickets may be purchased by anyone to attend this event.

The scholarship will be held in an investment account with First State Bank of Porter until the proceeds are paid to the chosen institution.

Money will be placed in a trust until beneficiary is enrolled at an institution of higher learning. Any growth income will be added to the value of the scholarship. The winner will be notified by telephone and through the US Mail.

Ticket buyers must be at least 18 years of age, although the winner's designated beneficiary may be of any age. The beneficiary may be changed by the winner. The winner is subject to all state and local raffle regulations and is responsible for the payment of any applicable taxes. Raffle tickets are not tax deductible. The Foundation, however, will recognize your contribution as a donation. Consult a financial advisor for additional information. Foundation staff, directors and members are ineligible to participate. Members of their families may participate.

Upon entering the raffle, the winner authorizes the use of his/her name and photographs for promotional purposes. The full scholarship will be awarded only if a minimum of 1000 tickets is sold. If fewer than 1000 tickets are sold, the gross receipts, minus the raffle expenses, will be split equally between the Duneland Education Foundation and the winner.
